#### 民間自發基金的巨大力量

2019 年 6 月,香港人發動了一場浩 大的反修例運動。612 人道支援基金 在運動中成立,將廣大市民的捐款, 為運動中勇敢投入的傷者及被捕者提 供醫療、法律、緊急經濟援助等人道 支援。在過去一年的工作中,我們看 到民間自發基金能發揮巨大力量,為 前所未見的龐大抗爭運動提供人道支 援,這規模和力量,應是世界少見。 基金最初成立之時,主要思維是濟急,只要能核實申請人符合基金宗旨訂明的支援範圍,便按其處境提供協助。運作的最主要原則為:保證申請人的身份保密,以及在此大前提下盡量公佈財務及工作概況。當時沒有預見這場抗爭運動規模之龐大、歷時之長久,以及政權鎮壓手段之殘暴和不受約束、抗爭者的犧牲重大、遭遇慘烈,以及將需要長期而持續的支援。

#### **Unprecedented Power of Spontaneous People-funding**

In June 2019, Hong Kong people started an anti-extradition bill movement that swept the city. The 612 Humanitarian Relief Fund was established with the generous donations of the public to give humanitarian relief such as medical, legal and emergency financial help to those who were injured or arrested while participating in the movement. In the past year of the Fund's operation, we witnessed the enormous power of the spontaneous funding by the people in plugging the gap in the huge need for humanitarian relief arising from this unprecedented movement. Its scale and power must be such as the world has rarely seen before.

At its inauguration, the Fund envisaged its mission as mainly one of giving emergency relief. So long as the applicant came within the object and scope of the Fund, relevant support would be provided according to the situation of the applicant. The two major principles of the Fund's operation are: strict confidentiality of the applicant's identity, and subject to that, maximum financial and operational accountability to the public. We did not foresee, then, that the movement would grow so large or last so long. Nor did we foresee the level and scale of the unrestrained brutality the regime exercised to suppress the movement, the terrible sacrifices on the part of the protesters, the maltreatment they endured, and therefore the need for continuous and long-term support in relief.

# 重大人道危機

基金的運作與運動一起成長,因應運動的需要,支援的範圍和數量在市民 踴躍捐款支持之下大幅增加。

由於還柙候審者日多,還柙時日久, 故基金設立還柙支援計劃,支援家人 探訪交通費、還柙日用品、書籍和私 飯等還柙物資。此外,基金透過資助 其他民間組織為我們未能直接接觸的 抗爭者,提供法律、醫療、緊急經濟 需要等人道支援。而針對公權力的非 法行徑的民事訴訟,是受害者唯一能 採取主動的法律制裁,然而訟費高 昂,基金是法援以外的資助途徑。 The operation of the Fund grows with the movement. In response to the needs of the movement, the Fund has expanded substantially its scope and volume of support thanks to generous public donations.

With growing numbers of persons on remand pending trial, and the duration of being held on remand also increasing, the Fund has set up a Remand Support Scheme to cover the costs of travel for family visits, daily supplies, books and private food for persons on remand. Through other civil organisations, the Fund also provides humanitarian relief such as legal, medical and emergency financial support to protesters with whom we do not yet have contact. Civil proceedings against alleged abuse of public power is the only legal recourse available to victims that they may themselves initiate. However such action is expensive so the Fund offers an alternative funding channel other than legal aid.

在佔支出最大比重的法律費用支援方 面,我們感謝三大熱線(民陣、民 權、星火)的義務律師團隊提供免費 的被捕法律支援。至於其他的法律服 務如保釋後會議、提堂、辯護等,則 一般須付律師費,基金因而訂定一套 可供查閱的付費項目、支援水平和方 式指引。鑒於捐款來自市民,基金的 付費水平以不高於公帑撥款的當值律 師及法援為原則。不論是否上述義務 律師團,我們都會按此水平支援。

無論在刑事辯護或民事訴訟上,基金 的指引和備忘錄都公開予公眾及業界 參閱,這個做法,亦可間接保障當事 人的權利。

同時,基金信託人有責任妥善管理基 金,務求賬目分明,開支得宜,在事 主需要與資助水平之際做到公平合 理。隨著基金支援範圍越趨廣闊及複 雜,信託人和工作團隊的職責也越趨 繁重,幸而基金得到各界人士擔任義 務顧問,隨時回應查詢,讓我們的決 策有具公信力的基礎。

Legal fees have been the largest item of expenditure of the Fund. We thank the voluntary groups of lawyers working through the 3 hotlines (Civil Human Rights Front, Civil Rights Observers and Spark Alliance) for their tireless efforts in rendering legal services to arrested persons in police stations on a pro bono basis. However, other legal services such as conferences after bail, representation in court for mention, trial etc generally require the payment, for which the Fund has drawn up guidelines setting out the items chargeable and the fee level. As the Fund is supported by donations from the public, the fee levels are set not to exceed Duty Lawyer/Legal Aid scale as a matter of principle. We will provide funding support based on these guidelines regardless of whether lawyers are from the voluntary groups. The relevant guidelines, for criminal defence or civil litigation, are accessible to the public for information. By doing so, would also be protected the interest of the clients.

The trustees of the Fund have the responsibility of ensuring the proper management of the Fund, including the transparency of its financial accounts, the appropriate use of the Fund, and striking a proper balance between the needs of the applicants and the reasonable level of assistance. As the areas and scope of assistance of the Fund increased and grew more complex, the responsibilities of the trustees and the working team also grew heavier. We are fortunate to be able to call on a team of volunteer advisors from a wide spectrum of professions and expertise who readily answer our enquiries as and when they arise. Their input has helped us to make our decisions on a sounder and more credible basis.

### 如水載舟 公民社會的靈活支持

過去12個月,最令我們感動及給予我 們最大鼓勵的,是公民社會廣大群眾 的關注與支持。今年5月初,基金在 財務簡報中顯示,主要由於法律費用 支出的飈升,基金所餘的可動用款項 已不足2,400萬元。這個數目,當然 不足以應付預計不下300多宗裁判法 庭的案件,消息一經發出,市民已主 動熱烈捐款,短短20天內,已有 19,500人次經銀行戶口或網上捐款, 一共捐出近2,400萬元。

靈活自發 — 顯示了香港人不凡的智 慧和力量。基金全人,在此深深感 謝,我們為香港人感到自豪!

反修例運動中,612 基金只是各民間 自發基金之中,規模較大並定期報告 工作及用款之一員,其他民間自發基 金不計其數,各按自己的目標、理 念、原則默默支援運動,可見民間支 援基金規模或大或小,都在這場運動 間逐漸建立起一個民間社會的自我保 護網絡。

#### Agile Support from Civil Society - As Water That Floats the Ark

Over the past 12 months, what moved us most deeply and gave us the greatest encouragement was the concern and support of the wide public and civil society. In early May, the Fund's financial summary report showed that the balance of available funds had dropped to under HK\$24 million, mainly due to a surge in expenditure in legal fees. This would be insufficient to meet the projected costs of the trial of some 300 magistrates court cases which the Fund has been assisting. As soon as the news was out, public support poured in. In just 20 days 19,500 donations were made to the Fund via bank transfer and online, making up a total of HK\$24 million!

Such agility and initiative demonstrated Hong Kong people's power and wisdom. We at the Fund are overwhelmed with gratitude, and can only say how proud we are of Hong Kong people!

The 612 Fund is only one among many of the community initiated funds established in the anti-extradition bill movement, and one which happens to be relatively sizable and well-known through its regular work and financial reports. There are countless other community funds formed by their own initiative, each with its own goals, ideas and principles, which have been quietly supporting the movement. From this we can see that community funds, big and small, together are gradually building up a self-protective network for civil society in the course of the movement.



#### 基金的未來方向

十二個月的運動顯示,香港現時面對 的最大危機已不是一項修例,而是特 區政府無法控制亦無意制止的浩大警 察暴力,以及在背後推動的殘民暴 政。警暴不止、不受調查、不受制 裁;法治脆弱,法律不能公平中立保 護市民,這場運動已發展為保衛自由 香港和下一代的未來的運動。 武漢肺炎疫情沒有令警暴暫緩,反而藉 公共衛生法規針對運動的支持者;同一 時間,越來越多抗爭者被加控暴動罪, 案件亦逐漸提上區域法院審訊,基金所 支援的法援分擔費亦日益增加。

但我們看到,香港人不會放棄抗爭;市 民抗爭之心不滅,民間自發、自資、毋 需任何人領導的行動和力量也不會消 散,基金短期內也難以放下責任。

#### The Way Forward

The 12 months of the movement has shown that the biggest crisis facing Hong Kong now is not just a proposed amendment to the law but the massive police brutality that the SAR Government has no power and no wish to control, and the autocratic regime which controls Hong Kong behind the scenes. Rampant police brutality, its immunity from independent inquiry and effective sanction, fragile rule of law, the inability of the law to remain neutral in protecting the rights of the citizen — this movement has become a campaign to defend free Hong Kong and the future of the next generation.

The outbreak of Covid-19 has not halted police brutality but instead given the government new ammunition in the shape of public health regulations to target supporters of the movement. At the same time, as more and more protesters were charged with rioting, and these cases were gradually brought to the District Court for trial, legal aid contributions supported by the Fund have also been growing.

But we have seen that Hong Kong people will not give up the fight. The people's will to resist is undiminished; civil society's power and action, self-motivated, self-funded, without need of a leader, will not disappear. The Fund cannot expect to lay down its responsibility in the short term.

長期抗爭,需要民間自發基金力量得 到維持和不斷發展。建立和維繫一個 守望相助的民間社會自我保護網絡, 是保障人民基本權利和生活品質的唯 一出路。這個民間社會的自我保護網 絡,包括各類由民間製造、為民眾服 務的生產社群,也包括能夠支持本土 生產的消費網絡,亦同時包含各類相 互支援的民間團體和社會組織。612 基金希望能夠參與建設這個民間社會 的自我保護網絡,成為其中一員,期 望有更多的民間團體和基金發揮力 量,承擔不同的支援工作。

612 基金現時範圍已極廣、負擔已極 大,不但不應求擴闊,反而應抗拒任 何因其規模而被視為「大台」的傾 向。基金應堅守崗位,繼續在所長的 領域,在各方支持之下做得更好。我 們應積極推動分散、分工、多元化、 各有所長而補不足,共同推動「民間 自發基金」運動,有越來越多、越來 越完善的民間自發基金,沒有大台, 各有自己的支援社群,沒有領袖,那 麼如水的抗爭運動就不會因任何一個 基金受阻而陷入困難。

Long term struggle requires continuing support and ever-growing funding from the community out of its own initiative. The only way forward to guarantee our basic rights and quality of life is by building and maintaining a strong system of mutual support civil society protection. This civil society self-protection net should include all kinds of production communities, and a consumer net that could support local businesses, as well as civil and social organisations that support each other. The 612 Fund hopes to play a part in building and participating in such a net as one of its members, and to see more civil society bodies and funds undertake different roles in providing a rich variety of support.

The present scope of the 612 Fund is already extensive, and its present responsibility already full. Not only should we not seek to further expand, we should indeed resist any propensity to appear in any way as a "main stage" because of the Fund's size. The Fund should continue to perform our duty unswervingly, striving to do ever better in the area of our strength with the support of the public. We should help to promote decentralisation, diversity and division of labour, so that together with other bodies we can supplement each other's strengths and initiatives, under a common objective to promote a "civil society initiative fund movement", so that there will be more and more and better and better organised funds, each promoting its initiative, no "main stage" ever, but each supported by its own community, no leader, then this "Be Water" movement will never be paralysed because of any particular fund falls into difficulties.

### "我更應該向前走"

2019年6月12日,站在現場的楊子俊 突然被一槍轟中右眼,眼前一片模 糊,右眼紅腫滲血。一年後過去,他 右眼視力只餘2.5%。他決定提出民 事訴訟控告警方,追究引致他受傷的 責任。作為社會運動的傷者,楊說要 好好利用「傷者」的身份,站出來指 控警暴。

不應該由年輕人承受,我相信 做的是對,更應該出來指證。

自受傷後,楊子俊比以前更關心在這 場運動身心受損的香港人。他發現不 少人在現場受傷,也不敢即時求醫, 遲了數天才到醫院應診,傷者生怕醫 管局將受傷名單交給警方,亦有很多 抗爭者或沒有到現場的年輕人都有或 多或少的創傷後遺症,但不敢求診。 - 楊子俊 612傷者、司法覆核申請人

「有些年輕人的家長是藍絲,年輕人 則想抗爭,社會的撕裂連繫到家庭, 這些青年的抑悶積壓在心,影響情 緒,甚至應該要向精神科求助。」

楊老師聽到很多受情緒困擾的青年, 有人願意求診,亦有年輕人不願意向 人傾訴,楊老師認為運動之後要向身 心受損的香港人提供更多的援助。

「眼前社會有很多問題,我看不到制度不改,會有改變的一天。打從『反修例』開始,這種『End Game』的絕望感是由成年人蔓延給年輕人。作為成年人,我更應該向前走,作出小的改變。」

堅持向警方追究失去右眼視力的責任,因為楊老師深信警方有責任展示號碼,要為自己的行為負責。楊老師認為之後的角色,是用實際的方法尋找公義,作為公民在極權之下更加堅持理念。



### "我們都會害怕被遺忘"

阿牛 曾還柙手足

上庭當晚宣布即時還柙後,阿牛(化名)登上囚車,在法庭停車場的出口外,旁聽師把囚車緊緊包圍,大湖住啊!」。每一句激勵的說話,打進他的心坎,一直處之泰然的他不禁留下男兒淚。「感動是因為我從來沒有預計到有這麼多人,包圍到囚車停了數分鐘,很誇張。我可以一直堅強是因為所有事情都是有心理準備,但這種支持聲援是意料之外。我們都會害怕被遺忘、被唾棄。」

或許我們很暴力、手法很極端,但 若同路人都唾棄我們做的事情,那 麼我們一切便沒有意義。

在收押所裡,他一生首次與世隔絕, 每天也只能見家人15分鐘,加上沒有 網絡,讓他「心理壓力很大」。後來 他從同期手足口中得悉申請獄中的各 種福利和「私飯」。雖然私飯的價錢 相對較高,但阿牛說「可以吃私飯好 重要」。 囚犯因入獄時間會被編往「同一期數」,除吃飯時間以外的時間都會在同一個生活空間,無法見到其他期數的囚犯。不少收押所內的手足由於一同申請私飯,在吃飯時間便可聚在一起。有時聊家人與朋友,有時談談抗爭去過日子,苦中作樂。「這個十分重要,因為有一班的手足去互相支撐,沒有那麼孤單。」

第二次上庭前,阿牛從來沒有想過能 過「重見天日」,「我走的時候還和 一同私飯期數的手足說:『不要把我 的飯菜全吃了,留一杯凍檸茶給 我』。」最後,法官以數十萬保釋 金、每日警署報到以及宵禁等條件批 准他的保釋申請。

自由雖無價,但他坦言對比其他案件,自己的「身價很貴」。從被捕時候的律師,到收押所中「私飯」、家人探訪的交通費,甚至是龐大的保釋金,談的都是「錢」。這些開支不是一個普通收入的家庭能夠負擔得起。阿牛說,「612基金減輕了被捕者的財政壓力。」



#### "無助之中伸出援手"

阿思 保釋義工

2019年入秋後香港的集會申請大多 遭警方反對,2020年警方則以疫情 為由,藉政府臨時頒布的「限聚令」 打擊集會自由。每次大圍捕的數目以 百計,在警署門外等候的家屬多達數 百人。阿思(化名)大半年前開始協 助被捕者家屬,他會從Telegram頻 道發出的相片確認被捕者的身份,等 待警署內公布的被捕者名單。

阿思形容家屬當中,忐忑不安有兩種,他們擔心子女被控《暴動罪》, 更害怕的是子女被虐打。一次,大班女仔在修頓被捕,去到警署,家屬一臉擔心跟我說:「會唔會有事架」,

#### 言談之間,我感受到家屬怕女兒被性侵。

家屬在警署外被折磨的程度視乎警署的做法,阿思慨嘆:「警署每次的做法不一。」警方不但遲遲不發放被捕者的名單,被告要求見律師,今日的警方會諸多借口:「今日太多人」、「未做晒程序」,讓律師在警署乾等一整天。現時被告有時要長達30小時才可以見律師,叫律師不眠不休苦苦等候。

阿思會陪伴家長在警署,有時帶兩、 三塊麪包進入警署果腹。縱使肚子咕 轆咕轆的響,有時不忍警署內的家屬 捱餓,將最後一塊的麪包遞到家屬手 上。阿思認為「家屬的等侍是最煎 熬。」

阿思憶述,一次大圍捕的被捕者大多 是18歲以下的青少年,他已收到消息,少年被捕者已進入保釋的程序, 家屬亦已獲通知帶領的保釋金,怎料 一個又一個家屬進入警署,原本打算 領子女,出來的只有家長。家長神情 呆滯,晃著空空軀殼跟阿思說:「保 釋不到,現在兒子是被告《暴動 罪》,明天上庭……。」整個加控的 過程連律師也蒙在鼓裡,律師立即要 求見人。家屬如何盼也盼不到子女出 來,阿思在警署門外逐一安撫百名家 屬,遞紙巾,互相拍肩勉勵,有家屬 直言情緒陷崩潰,需要心理輔導。

被捕之後,家屬和被捕者在風雨飄搖 的日子,需要更多的情緒支援,阿思 希望在無助之中,伸出援手,幫助他 們。

被捕法律支援: 612 基金不設律師團隊。當接獲被捕支援求助,會按事主意願,把資訊轉交予相應被捕支援平台,務求使被捕者盡快得到律師支援;若是私人聘請律師,基金會按「法律支援計劃」資助法律費。

**保釋後會議**:基金按「法律支援計劃」資助法律費。

保釋金:基金可即時到警署借出,亦可由事主先付,事後再向基金申請借出。

<u>緊急經濟援助</u>:因被捕導致經濟困難,可申請緊急經濟援助。

親友情緒支援: 可向事主親友提供支援,如探監經驗分享、陪伴或是情緒支援,或轉介專業社工/輔導員

個別跟進,或參與家長/子女/伴侶互助小組。





## 立足當下 繼續拓展

#### 範圍不變

支援及保護因反送中運動而被捕、被告的 抗爭者,包括審訊、還柙、服刑及出獄後 的人道支援,繼續提供法律費用、醫療 / 心理輔導費用、緊急經濟援助、還柙支援 等等。

#### 增設服務

- A. 設立審訊期間緊急經濟援助;
- B. 探討服刑期間的支援,訂立詳情及指引;
- C. 基金會積極參與探討手足出獄後的支援,此 方面範圍廣闊,包括復學、就業、重返社會 等,將需要多方面民間組織共議策劃安排;
- D. 專業界共議,探討長期社區復原的計劃和服務,期望協助推動這方面更多元化的民間支援網絡。

#### 民事訴訟資助

為使基金能在謹慎運用資源的情況下 支援相關的民事訴訟,基金須訂立良 好的資助程序和資助水平,並會在適 當的情況下,為個別案件發起眾籌, 並就該項眾籌提供首筆資助以祈鼓勵 民間參與。

#### 推動「民間自發基金」

推動多元發展,編織民間社會的自我保護網絡。

#### 支援倡議、追究

支援與反修例抗爭者直接有關的人權 倡議和追究警暴。
